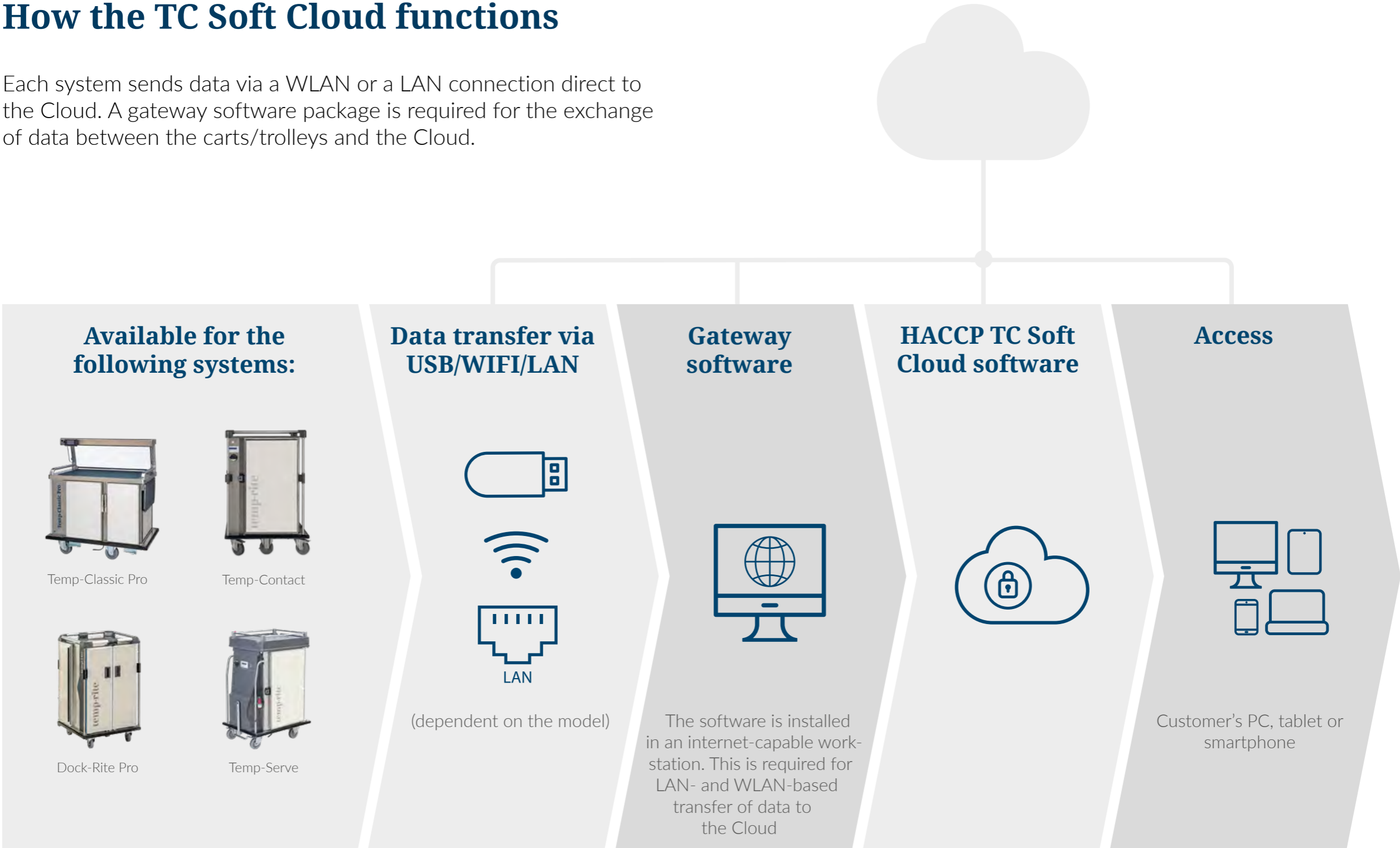

How the TC Soft Cloud functions

Each system sends data via a WLAN or a LAN connection direct to the Cloud. A gateway software package is required for the exchange of data between the carts/trolleys and the Cloud.







How the TC Soft Cloud is used

- The TC Soft Cloud package is licensed software. A licence, which is valid for 2 years, is required for each unit operated by the customer
- Each customer receives a three-level access-rights system for the use of the software. The three levels (customer – manager – user) define given sets of rights. Each person sees only what is relevant to his/her duties and activities.
- Login is by means of a user name and a password entered via a browser
- All the carts/trolleys registered in the Cloud are displayed on the dashboard. An intuitive navigation-and-software interface guarantees high acceptance rates with users.

Application, test and contract-signing phase

Application analysis

- Tests to establish which systems the TC Soft Cloud can be used with (pre-existing systems, new systems)
- Systems already being used can be retrofitted with the necessary modules (testing is in this case essential)

Technical checks

- Checks to establish that all the technical pre-requirements for use of the TC Soft Cloud have been met
- We recommend the involvement of, and direct communication between, temp-rite's and the customer's own IT specialists

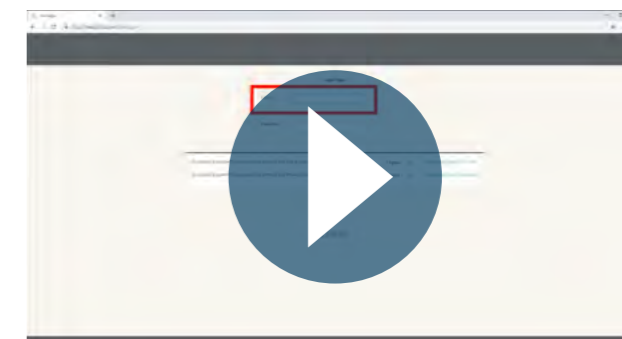
Signing of the contract

- The use of the TC Soft Cloud software package is subject to a licence agreement. For reasons connected with data-protection and privacy law, this agreement will involve the drawing up of a contract covering:
 - supply of the software
 - data protection and an end user licence agreement (EULA)
 - licensing of the cart/trolley for 2 years

Implementation phase

Granting of the licence, adding systems to the cloud, customer training

- The assignment of contracts to carts/trolleys in the customer's fleet is undertaken by temp-rite
- temp-rite sets up the customer's account and provides training for selected managers (key users)
- Easy-to-follow instructional videos explain all of the main system functions. These how-to videos remain available for reference and for post-implementation instruction of further employees
